That in consideration of **EIGHT HUNDRED EIGHTY FIVE THOUSAND FIVE HUNDRED FIFTY EIGHT AND 00/100 DOLLARS (\$885,558.00)** to the undersigned grantor, **Blackridge Partners, LLC, an Alabama Limited Liability Company**, (herein referred to as GRANTOR) in hand paid by the grantees herein, the receipt whereof is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto **Phillip K. Huff and Gale D. Huff**, (herein referred to as Grantees), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

**SUBJECT TO ALL MATTERS OF RECORD**

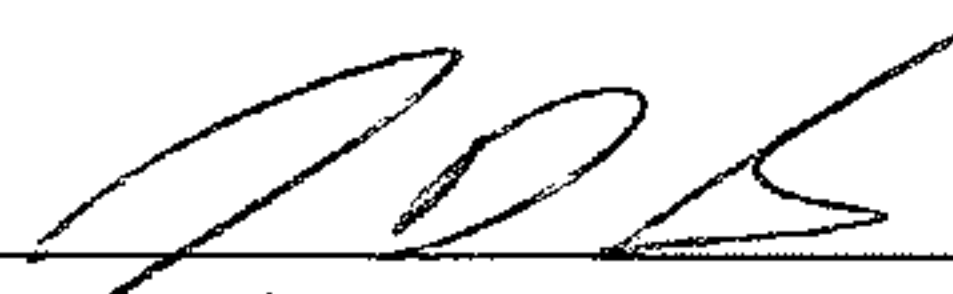

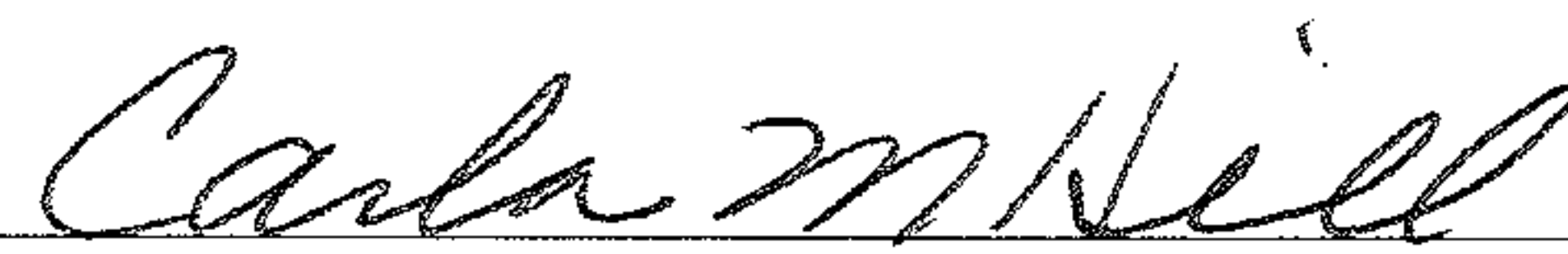

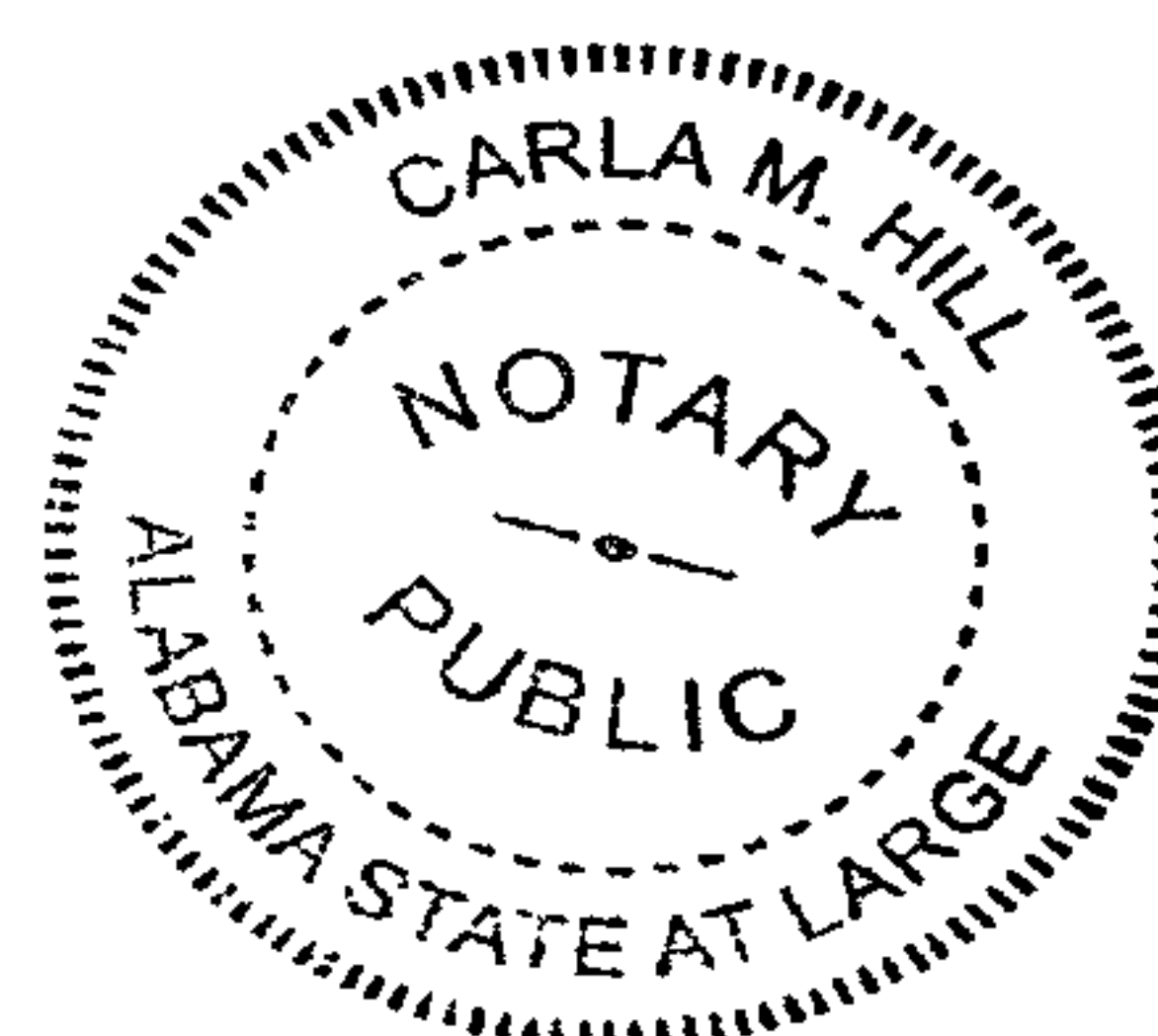
