Affiant states that his/her relationship to the Decedent was that of Friend / Neighbor (state relationship to decedent).

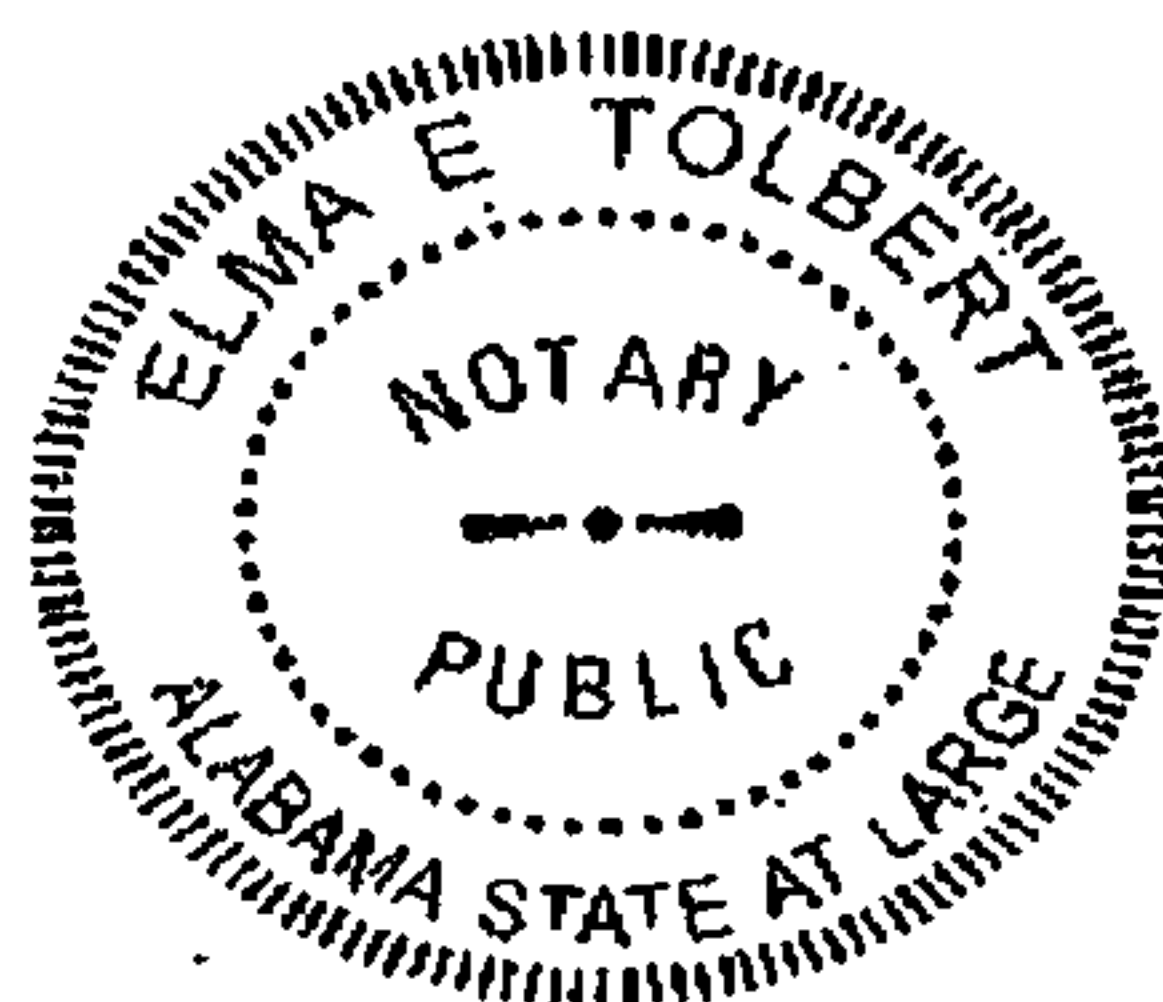
