That in consideration of Two Hundred Ninety-Nine Thousand One Hundred Fifty and 00/100 (\$299,150.00) Dollars and other good and valuable consideration paid in hand by the GRANTEE herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Sherron Tarver (herein referred to as GRANTEE), all of its right, title and interest in and to that certain real estate situated in Shelby County, Alabama, to-wit:

Lot 124, as shown on the Final Plat Koslin Farms Phase 2, Sector 1, according to the map or plat thereof, recorded in Plat Book 57, Page 85, in the Office of the Judge of Probate of Shelby County, Alabama.

Mineral and mining rights excepted. Subject to: current taxes not yet due and payable, conditions, covenants, easements, exceptions, limitations, reservations, and restrictions of record.

The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.

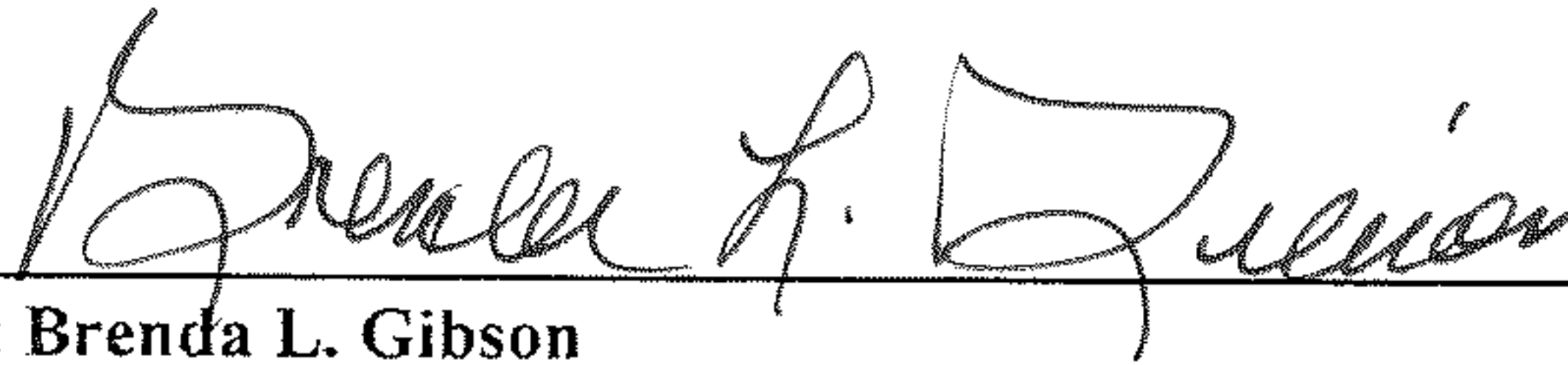
