
DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, **JANAKI RAM PRASAD EARLA**, of 1690 Lake Cyrus Club Drive, Hoover, Alabama 35244, being over the age of nineteen years and being of sound mind, do hereby revoke any Power of Attorney previously executed by me and do hereby appoint my wife, **NEELAVENI KALLEMPUDI**, of 1690 Lake Cyrus Club Drive, Hoover, Alabama 35244 to serve as my Attorney in Fact to exercise the herein powers. My wife, **NEELAVENI KALLEMPUDI**, shall have the following powers, duties, and authorities:

1. To ask, demand, sue for, collect, recover, and receive all sums of money, debts, accounts, interest, dividends, annuities and demands whatsoever as are now or shall hereafter become due, owing, payable or belonging to me.
2. To draw checks and make deposits in my checking account or accounts, to make withdrawals or deposits in my saving account or accounts, to obtain the balances in any said accounts, to access any safety deposit boxes and the contents thereof, and to perform all functions relating to my banking affairs.
3. To sell, exchange, purchase, invest, and liquidate stocks, bonds, mutual funds, certificates of deposit, annuities and any other type of asset of investment.
4. To buy, sell, lease, mortgage, sub-divide, or manage real estate.
5. I grant to my attorney-in-fact full power and authority to do, take, and perform each and every act or thing whatsoever necessary or proper to be done, in the exercise of any of the rights and powers granted in this instrument, as fully to all intents and purposes as I might or could do if personally present, with full power of substitution or revocation, and by this instrument I ratify and confirm whatever act or thing that my attorney-in-fact shall lawfully do or cause to be done by virtue of this durable power of attorney and the rights and powers granted by this instrument.
6. I give and grant to **NEELAVENI KALLEMPUDI** full power and authority to do and perform every act, whether specifically enumerated herein or not. I hereby ratify and confirm all that **NEELAVENI KALLEMPUDI**, as my true and lawful Attorney in Fact, shall do or cause to be done by virtue of this Durable Power of Attorney.
7. This instrument is to be construed and interpreted as a durable power of attorney. This power of attorney shall not be affected by disability, incompetency, or incapacity of the principal, except as provided by statute.


