KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of THREE HUNDRED FORTY FIVE THOUSAND AND 00/100 (\$345,000.00), and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS, **RICHARD TINNELL, A MARRIED PERSON; THOMAS KEITH TINNELL, A MARRIED PERSON; and CHRISTOPHER LEE TINNELL, A MARRIED PERSON** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEE, **NINA L. TARPLEY** (herein referred to as GRANTEE), his/her heirs and assigns, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

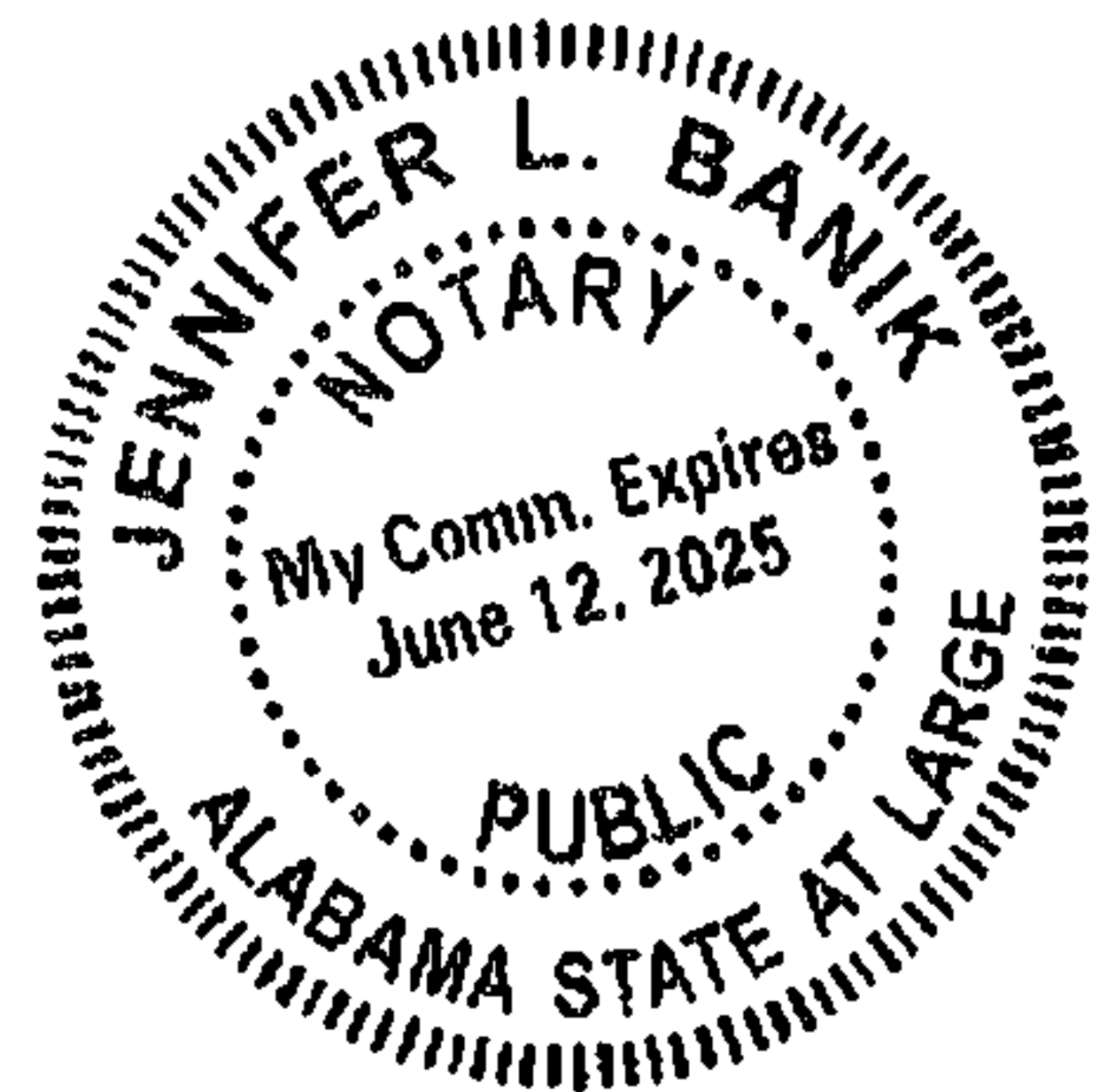
