NOTICE OF PAYMENT

TO ALA. CODE § 26-2A-6 (1975)

Comes now Stefanie Michelle Clarke (hereafter, "Obligor") and Stefanie Michelle Clark, (hereafter, "Payee") pursuant to Ala. Code § 26-2A-6 (1975), and being first duly sworn state as follows:

1. Obligor is under a duty to pay or deliver money consisting of the following sums to the following individuals, (hereafter, the "Minors") each of whom are minor children, to-wit:

- a. The sum of \$5,224.52 (Five Thousand Two Hundred Twenty-Four Dollars and 52 Cents), to NOAH BLAKE PUCKETT;
- b. The sum of \$5,224.52 (Five Thousand Two Hundred Twenty-Four Dollars and 52 Cents), to EMMA GRACE PUCKETT; and
- c. The sum of \$5,224.52 (Five Thousand Two Hundred Twenty-Four Dollars and 52 Cents), to DANIEL ISAIAH PUCKETT.

2. Alabama law provides that any person under a duty to pay or deliver money or personal property to a minor child (subject to the maximum values set forth in Ala. Code § 26-2A-6(a), and only so long as the person making such payment or delivery does not have actual knowledge of the appointment, or of a pending petition for appointment, of a conservator of the estate of the minor child) may perform the duty by paying or delivering the money or personal property to (1) Any person having the care and custody of the minor and with whom the minor resides; (2) A guardian of the minor; or (3) The judge of probate of the county in which the minor resides, if a resident of this state, or, if a nonresident, to the judge of probate or like officer of the county in which the debtor or creditor resides;

3. Payee Stefanie Michelle Clark states that she is a person having the care and custody of the said Minors, as contemplated by Ala. Code § 26-2A-6(a), and that all of the said Minors reside with Payee in Shelby County, Alabama;

4. Obligor avers that she has no actual knowledge of either (a) the prior appointment of a conservator for any of the said Minors, or (b) any pending proceeding for the appointment of a conservator of the estate of any of the said Minors;
