The grantor herein Teresa Ray acquired the above property in the deed recorded in Instrument 20140819000259680 as Teresa Ray-Connell.



- Subject to:



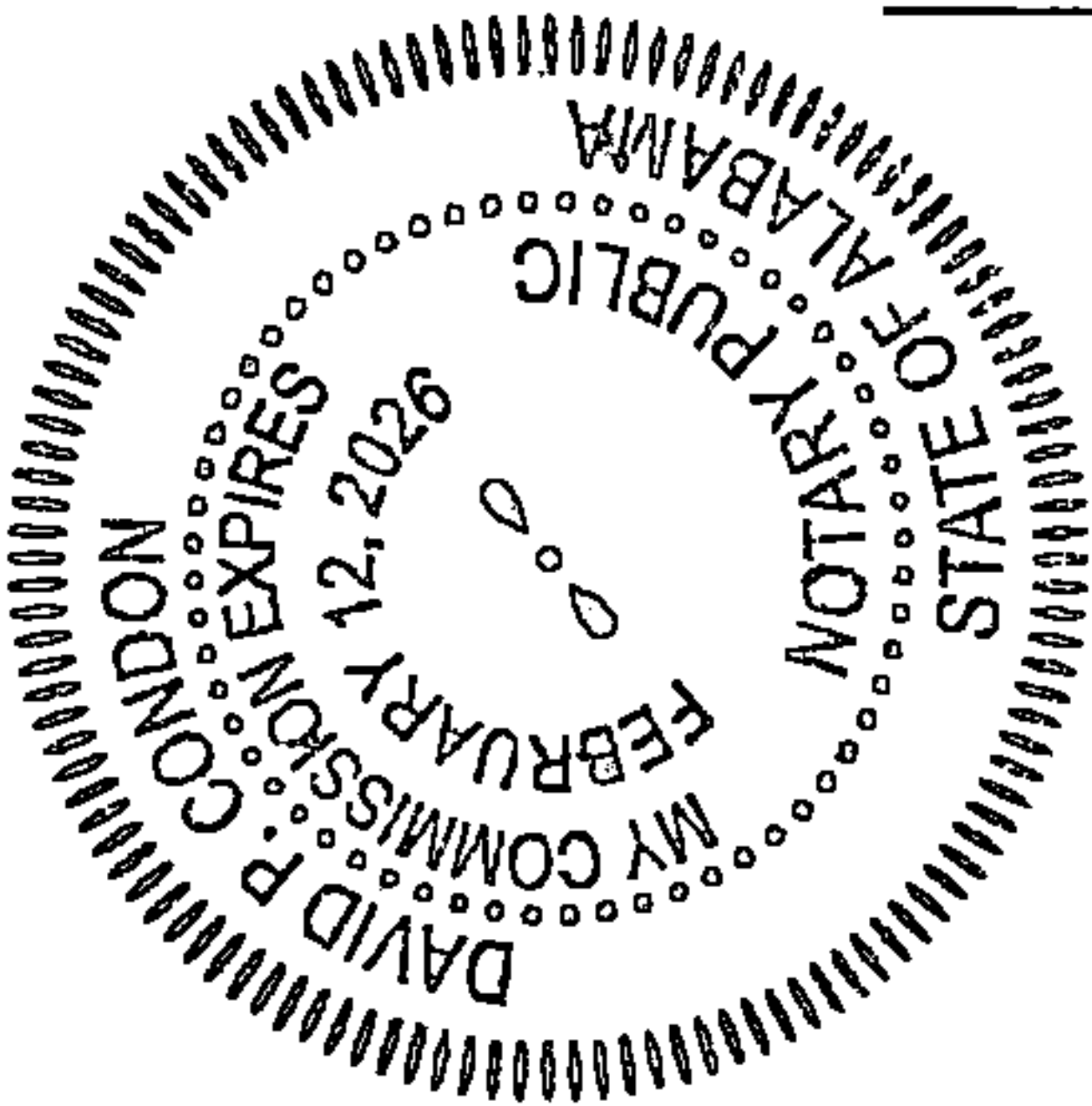
