MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That

WHEREAS, heretofore, on, to-wit: the 11th day of July, 2008, MACDONALD B FLEMING, SURVIVING SPOUSE OF IMA JEAN FLEMING, WHO DIED ON FEBRUARY 27, 1997 IN SHELBY COUNTY, AL executed that certain mortgage on real property hereinafter described to COUNTRYWIDE BANK, FSB, which said mortgage was recorded in the Office of the Judge of Probate in Shelby County, Alabama, on August 20, 2008, at Instrument Number 20080820000335620, Shelby County, Alabama Records, said Mortgage having subsequently been transferred and assigned to **GREENSPRING CAPITAL MANAGEMENT LLC, NOT IN ITS INDIVIDUAL CAPACITY, BUT SOLELY AS ADMINISTRATOR OF THE RMH 2023-2 TRUST**, by instrument recorded in at Instrument Number 20240308000063980, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, in and by said mortgage, the Transferee was authorized and empowered in case of default in the payment of the indebtedness secured thereby, according to the terms thereof, to sell said property before the Courthouse door in Shelby County, Alabama, after giving notice of the time, place, and terms of said sale in a newspaper published in said County by publication once a week for three (3) consecutive weeks prior to said sale at public outcry for cash, to the highest bidder, and said mortgage provided that in case of sale under the power and authority contained in same, the Transferee or any person conducting said sale for the Transferee was authorized to execute title to the purchaser at said sale; and it was further provided in and by said mortgage that the Transferee may bid at the sale and purchase said property if the highest bidder thereof; and

WHEREAS, GREENSPRING CAPITAL MANAGEMENT LLC, NOT IN ITS INDIVIDUAL CAPACITY, BUT SOLELY AS ADMINISTRATOR OF THE RMH 2023-2 TRUST was the highest bidder in the amount of Two Hundred Twenty-Four Thousand Nine Hundred and 00/100 dollars (\$224,900.00), on the indebtedness secured by said mortgage; and GREENSPRING CAPITAL MANAGEMENT LLC, NOT IN ITS INDIVIDUAL CAPACITY, BUT SOLELY AS ADMINISTRATOR OF THE RMH 2023-2 TRUST, by and through its undersigned counsel, does hereby grant, bargain, sell and convey unto GREENSPRING CAPITAL MANAGEMENT LLC, NOT IN ITS INDIVIDUAL CAPACITY, BUT SOLELY AS ADMINISTRATOR OF THE RMH 2023-2 TRUST, all of its right, title, and interest in and to the following described property situated in Shelby County, Alabama, to wit:

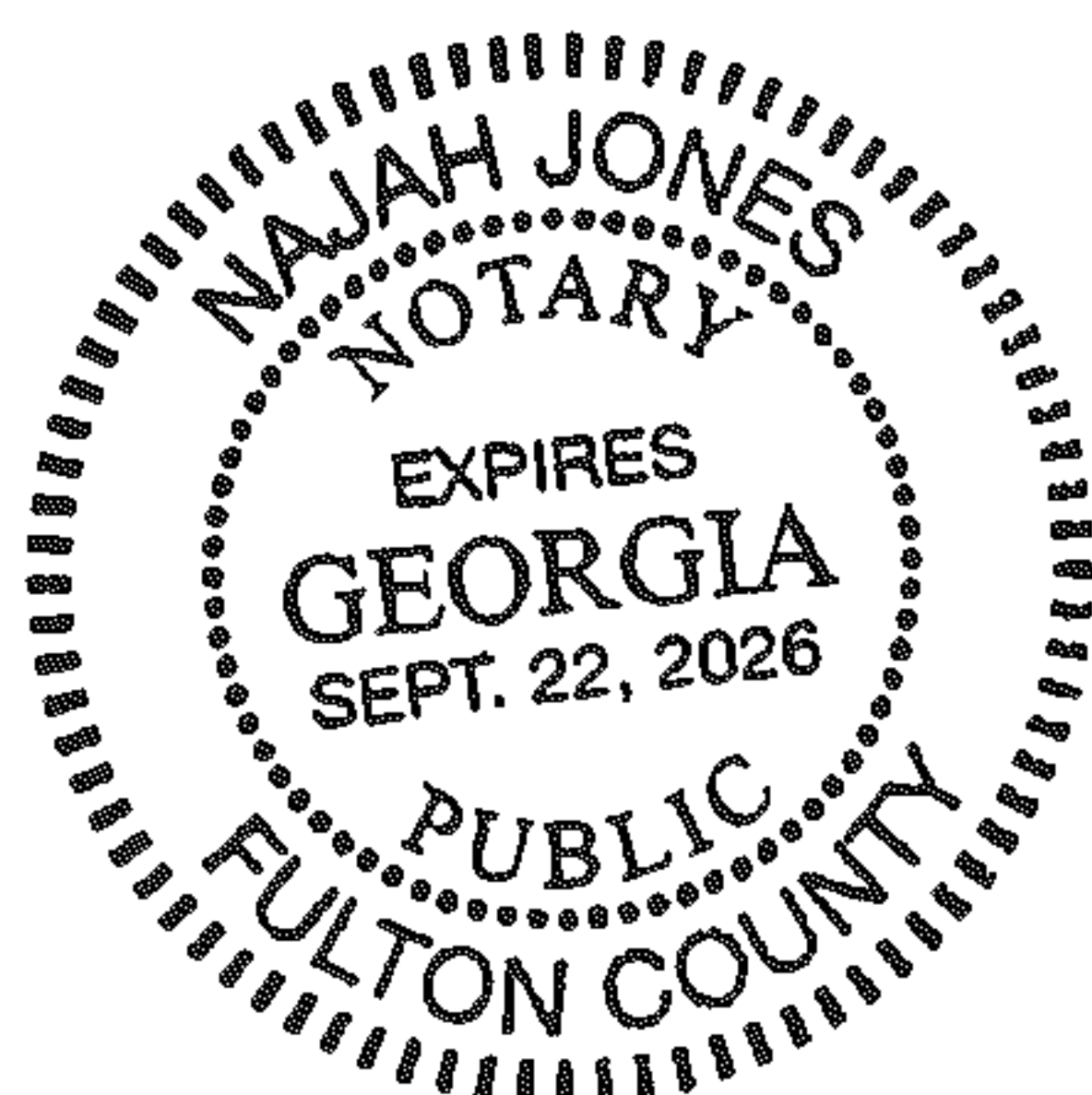
