

ORDER

This matter came before the Court on Omaha Property Manager, LLC's (hereinafter "Omaha"), Planet Home Lending, LLC's (hereinafter "PHL"), Wilmington Trust, N.A. solely as Trustee for MFRA Trust 2015-1's, improperly designated as Wilmington Trust, N.A. (hereinafter "Wilmington"), and M&T Bank's (hereinafter "M&T"), Motion for Final Summary Judgment.

- 1. Through counsel for Oscar and Tammy Shanks (hereinafter "Defendants/Counter-Plaintiffs"), the Court has learned that Defendants/Counter-Plaintiffs have died. Suggestions of death have been filed for both decedents;
- 2. Defendants/Counter-Plaintiffs have consented to the entry of a judgment in favor of Omaha Property Manager, LLC on its ejectment claim against them; and
- 3. Defendants/Counter-Plaintiffs agree to dismiss their counter-claims against Omaha Property Manager, LLC, with prejudice.

Therefore, the Court ORDERS, ADJUDGES, and DECREES as follows:

1. As a consequence of Defendants'/Counter-Plaintiffs' death, this case shall be removed from this Court's May 9, 2024 trial docket and will be re-set once a

personal representative has been substituted into the case;

- 2. Omaha Property Manager, LLC is hereby awarded a judgment for possession of the real property located at 9439 Brook Forest Circle, Helena, AL 35060-3456 (the "Subject Property");
- 3. All right, title, and interest in the Subject Property is vested solely in Omaha Property Manager, LLC;
- 4. Defendants'/Counter-Plaintiffs' heirs shall coordinate the removal of any of Defendants'/Counter-Plaintiffs' personal property from the Subject Property through counsel;
- 5. Defendants/Counter-Plaintiffs shall remove all personal property from the Subject Property, during business hours, within fifteen (15) calendar days of this Order;
- 6. Any personal property remaining on the Subject Property after that time shall become the property of Omaha Property Manager, LLC to dispose of at its discretion;
- 7. All of Defendants'/Counter-Plaintiffs' counter-claims against Omaha Property Manager, LLC are hereby dismissed, with prejudice, and costs are to be taxed as paid;
- 8. Defendants'/Counter-Plaintiffs' claims against Planet Home Lending, LLC, Wilmington Trust, N.A. solely as Trustee for MFRA Trust 2015-1, and M&T Bank remain pending and are not affected by this Order; and
- 9. The remaining Counter-Defendants' Motion for Summary Judgment shall be re-set for hearing once Defendants'/Counter-Plaintiffs' personal representative has been substituted into the case.
