This Indenture made this seventeenth day of Febry.
one thousand eight hundred and twenty six
between Uriah Jordan & Barbara his wife of the
County of Shelby & State of Alabama, of the one part &
and James A. Previtt of the other part,
Witnesseth that the said Uriah Jordan & Barbara his wife
for and in considerations of the sum of one hun-

dued dollars to them in hand paid the receipt
 whereof is hereby acknowledged that this day
 bargained, sold, alined, enfeoffed, and conveyed
 and by these presents doth bargain sell, aline
 enfeoff and convey unto the said James A. Brew-
 itt all that certain piece, parcel or tract of land
 lying & being in the County aforesaid being the
 west half of the north East quarter, of section
 twelve in township twenty of range then set in
 the district of Tuscaloosa and State of Alabama
 containing nearly nine acres, and eighty two
 hundredths of an acre, according to the official
 plat of the survey of the said lands returned
 to the General Land office by the Surveyor Gen-
 eral, conveyed to the said Uriah Jordan from
 the United States by a patent dated the fourth
 day of May in the year eighteen hundred
 and twelve four number of certificate, 9739.
 Recorded in Vol. 6 page 169 to have and to hold
 the above described tract of land with the ten-
 ments and appurtenances thereto belonging
 or in anywise appertaining unto the said
 James A. Brewitt his heirs & assigns forever. The
 said Uriah Jordan & Barbara Jordan his wife
 for themselves, their heirs, executors, and ad-
 ministrators doth warrant & will forever defend
 the title to the above described & hereby granted
 premises unto the said James A. Brewitt & his
 heirs and assigns from & against themselves
 and all and every person or persons claiming
 or holding under them the said Uriah & Barbara
 his wife, and also against the lawful title claim
 or demand of all and every person or persons
 whomsoever claiming or holding by from or
 under the Government of the United States in
 testimony whereof the said Uriah Jordan and
 Barbara his wife have hereunto set their hands &
 seals the day & year above written
