 August one thousand eight hundred and twenty
 nine between David Neil of the County of St. Clair
 and State of Alabama, of the one part and Clayton
 Thompson of the State and County of Jefferson
 of the other part, witness. That the said David Neil
 for and in consideration of the sum of fifteen hun-
 dred Dollars to him in hand paid the receipt whereof
 is hereby acknowledged hath this day bargained
 sold aliened, released and conveyed and by these
 presents doth bargain sell, alien release and con-
 vey unto the said Clayton Thompson all that
 certain tract or parcel of land lying and being
 in the State and County offoresaid & being the
 west half of the South west quarter of section
 twenty nine of township seventeen of Range one East
 in the District of Tuscaloosa and State of Alabama
 containing twenty nine acres $\frac{9}{100}$ of an acre, & also
 the west half of the north west quarter of section
 twenty nine of township seventeen of Range one East
 in the District of Tuscaloosa, and State of Alabama
 containing twenty nine acres $\frac{9}{100}$ of an acre to have
 and to hold the above described two half quarters
 of land and by present premises with the ten-
 ments and appurtenances thereunto belonging or
 in anywise appertaining unto the said Clayton
 Thompson to him and his heirs & assigns for
 ever, and the said David Neil for himself his
 heirs and assigns forever executors and adminis-
 trators with warrant and seal present before
 the date to the above described and hereby granted
 premises unto the said Clayton Thompson to him

and her heirs and assigns from and against myself my heirs, executors and assigns all and every person or persons claiming or holding under him the said David Neel and also against the lawful title claim or demand of all and every person or persons whomsoever claiming or holding from or under the Government of the United States.
