

Baldmire Robt. This instrument made the 18th day of March in
 the year of our Lord one thousand eight hun-
 dred and thirty two between Robert and
 Jane M. Caldwell of the County of Shelby State
 of Alabama of the one part and Lainals Coss
 of the County and State aforesaid of the other
 part, witnesseth that the said Robert and Jane
 M. Caldwell for and in consideration of the
 sum of Two hundred and fifty Dollars to them
 in hand paid by the said Lainals Coss
 at and before the signing and delivery of these
 presents the receipt whereof is hereby acknowl-
 edged to have been paid and sold and by the
 presents, doth say and sell unto the said
 Lainals Coss, his heirs and assigns a certain
 tract or parcel of land lying and being in
 the County of Shelby and State of Alabama
 and known by the East half of the North-East
 quarter, of certain forest in lower Shipp,
 twenty of range three west in the district
 of Tuscaloosa containing eighty acres, and
 three hundredths of an acre to have and to
 hold the said tract or parcel of land with
 the timber and hereditaments and all
 and singular other the premises hereinbefore
 mentioned or intended to be bargained and
 sold and every part and parcel thereof unto the
 said Lainals Coss, his heirs and assigns forever.
 And the said Robert and Jane M. Caldwell
 for themselves and their heirs the said tract
 of land with all and singular the premises or
 appurtenances before mentioned unto the said
 Lainals Coss his heirs and assigns free from
 the claim or claims of them the said Robt.
 and Jane M. Caldwell and their heirs and
 all and every person or persons whatsoever,
 shall and will and do warrant and forever
 defend by these presents.
 In witness whereof the said Robert and Jane
 M. Caldwell have hereunto set their hands &
 seals the day & year first above written
