To Shelly County. This eleventh day of  
Arthur Nabors February in the year of our Lord one thousand  
Page 195 eight hundred and twenty eight between David  
Meredith and Sally Meredith his wife of the  
one part, and Arthur Nabors of the other part  
both of the State and County aforesaid wit-  
nesseth that the said David and Sally Mer-  
edith his wife for and in consideration of one  
hundred dollars to them in hand paid by  
the said Arthur Nabors the receipt whereof is  
hereby acknowledged have granted bargained  
sold and by these presents doth grant, bar-  
gain, sell and convey unto the said Arthur  
Nabors, a certain piece or tract of  
land lying and being in the County aforesaid  
containing twenty eight acres and fifty four

deedth of an acre, being part of the West  
half of the South East quarter or section  
four in township twelve one in range  
three West, of the lands sold at Tuscaloosa  
beginning on the South West corner of said  
half quarter section thence south with the  
line of the same, fifty seven rods, then  
East eighty rods, to the East line of said  
tract thence South fifty seven rods,  
with said line to the South East corner  
of said tract thence west with the south  
boundary of said tract eighty rods to the  
beginning, I, have and to hold the said  
tract of land with all and singular  
the rights, privileges, hereditaments  
thence holding or appertaining to the  
said Arthur Walms, his heirs & assigns  
& from the said David Meredith and  
Sally his wife their heirs assigns &  
the title to which said tract of land  
the said David & Sally Meredith his wife  
will warrant and forever defend against  
all manner of persons whomsoever claiming  
under the government of the United States  
or territory whereof the said David and  
Sally Meredith have hereunto set their hands  
and affixed their seals the day & year before  
written signed sealed & delivered in presence of
