John W. Popper & Joseph Popper their heirs to
advertise & sell according to said deed of trust
the following land lying in said county
to wit the west half of the north east quarter
of sect 4 T 21 R 1 east west 1/2 north east quar-
ter lot 3 T 21 R 1 east east 1/2 north east
quarter sect 4 T 21 R 1 east also east half
south west quarter sect 4 T 21 R 1 east in
Tuscaloosa land district whereas the said
Silas Pitts & John Cullingham have made defau-
lt in the payment of the said sum of money
in said trust deed specified & whereas the

 forever the land aforesaid as fully & partic-
 ularly as can under the authority aforesaid
 to have & hold the said land & premises
 with the appurtenances thereto belonging in
 testimony whereof witness my hand & seal
