 Wilson M Kidd } This indenture made  
 the tenth day of May in the  
 year of our Lord one thousand  
 eight hundred and forty eight between Nathan  
 Primm of the one part and Wilson M Kidd of  
 the other part each of the County and State afo-  
 said witnesseth; that as the said Nathan  
 Primm in and by a certain obligation under his  
 hand bearing even date herewith stands bound unto  
 the said Wilson M Kidd in the sum of forty seven  
 dollars with lawful interest for the same, and  
 that the said Nathan Primm, as well for and  
 in consideration of the aforesaid debt or sum of  
 forty seven dollars and for the better securing the  
 payment thereof with its interest, as also for  
 & consideration of securing the said Wilson M Kidd  
 from the payment of a note which he secured  
 given by the said Nathan Primm to ~~Wiley~~ ~~Wiley~~  
 for ninety six dollars the note being credited  
 with thirty dollars; in discharge of the said noted  
 obligations, as of the further sum of one dollar to  
 him in hand paid by the said Wilson M Kidd  
 at and before the sealing and delivery hereof the  
 receipt whereof is hereby acknowledged, hath gran-  
 ted, bargained, sold, released and confirmed and  
 by these presents doth grant bargain sell re-  
 lease and confirm unto the said Wilson M  
 Kidd his heirs and assigns all that parcel of  
 Land lying and being designated as the south half  
 of the west half of the S W Quarter of section thirty  
 four Township 19 Range 2 East together with all  
 improvements rights privileges and appurtenances  
 whatsoever thereunto belonging to have and to hold  
 the said tract or parcel of Land &c. hereby granted  
 or intended so to be, together with one wheat  
 thrasher with the appurtenances unto the said  
 Wilson M Kidd his heirs and assigns to the only  
 proper use and behoof of the said Wilson M Kidd  
 his heirs and assigns forever. Provided always  
 nevertheless that when the said Nathan Primm  
 his heirs executors and administrators shall and  
 do well and truly pay or cause to be paid unto  
 the said Wilson M Kidd, his executors, administrators  
 or assigns the aforesaid debt or sum of forty seven

dollars with interest; and provided also that when the said Nathan Primm shall have paid the aforementioned note of ninety six dollars to Willie Pope thereby releasing the said Wilson M Kidd as security there and from thenceforth as well this present indenture, and the estate hereby granted as the said recited obligation shall cease determine and become absolutely null and void any thing herein contained to the contrary notwithstanding.
