 his heirs and assigns forever so that we the said
 James M. Nabors and Daniel E. Watrous no any
 other person in our name or behalf shall or
 will hereafter claim or demand any right or
 title to the premises aforesaid or any part thereof
 but they and every one of them shall by these presents

Also included and for ever have a said tract of Land was conveyed to us by Jacob D. Shelly Sheriff of said County by be a record in the office of the Clerk of said County Pages 53, 53. & 54 of Book D, sold as the property of Thomas L. Davis by Writ of Summary executions against him and all such title as was conveyed to us by said Sheriff and is hereby conveyed to the said Andrew Harkins his heirs and assigns forever against us and all claiming by or through or under us
