 Abraham Smith } between Rhoda Harvard of the
 first part and Abraham Smith of the second part
 Witneseth that for and in consideration of the sum of
 one dollar in hand paid by Abraham Smith
 before the signing and sealing & delivering of these
 presents do this day transfer set over and deliver unto said
 Smith all my right title interest and claim of all the
 following lots or parcels of land known and designated
 by being the $\frac{1}{2}$ of $\frac{1}{4}$ of section No twenty six also
 the N.W. $\frac{1}{4}$ of $\frac{1}{4}$ of the same section also the N.W. $\frac{1}{4}$
 of N.E. $\frac{1}{4}$ of section thirty five all in Township 18th
 Range 9 East containing one hundred & fifty acres
 more or less and also the following property and
 Wagon worth fifty five dollars one yoke of oxen
 worth thirty dollars one head of sheep fifteen

Dollars and Two Cents worth two dollars on the fol-
lowing expressed conditions whereas the said Rhoda
Haward of the first part is justly indebted to the
said Abraham Smith of the second part by a receipt
for the redelivering of a note for one hundred & sixty
dollars debt & interest being date Jan. 8th 1841 also
one short receipt given by W^m H. T. and are of
Shelby County five hundred and three dollars and
twenty nine and one fourth cents and interest for some
seven months being date Decem^r 15th 1847 being
security of Abraham Smith and he for estate &c
expressed in the face of said receipts now if said Rhoda
Haward fail to pay to the said Abraham Smith
or to his Lawful Attorney the whole amounting
at present to six hundred eighty seven dollars &
Eighty five cents with interest from the present date
on or before the 15th of December 1857 and in case
said Rhoda Haward should fail to make -
payments by that time in that case I Rhoda
Haward do authorize and empower the said Abraham
Smith of the 2^d part to advertise the above described
Land & property in the Record of Columbia and giving
thirty days notice and sell to the highest bidder
for cash and apply so much of the proceeds of said
as will satisfy and pay the above described receipts
and in case the Land & property is sold I do in the presence
of the undersigned Witness Appoint Abraham Smith
of the second part my Lawful agent to make a good
and Lawful title the purchase of said Land & property
in my name which I acknowledge shall be as
binding on me as if done personally by myself -
