 to them in hand paid the receipt whereof is hereby
 acknowledged have this day bargained granted
 sold aliened enfeoffed and conveyed and by these
 presents do bargain sell enfeoff and convey to
 the said party of the 2nd part all that certain
 tract or parcel of land lying and being in the
 County of Shelby and State of Alabama and
 known and distinguished in the plan of
 survey of said Co. as the E¹/₄ S¹/₄ & S¹/₄ E¹/₄ of
 Section 33 also N¹/₂ S¹/₄ of Section 34 Township
 21 Range 2 N & the S¹/₄ E¹/₄ & E¹/₄ S¹/₄ and the
 N¹/₄ E¹/₄ & S¹/₄ E¹/₄ of S¹/₄ of Section 4 Township
 22 Range 2 West To have and to hold the above
 described tract or parcel of land together with all
 the tenements and appurtenances therunto belong-
 -ing as in any case appertaining unto the said
 William Harkins and the said party of the 2nd
 part themselves their heirs, executors and admin-
 -istrators do warrant and well forwired and

the title to the above described and hereby granted
 premises unto the said William Starkins his heirs
 and assigns from and against them and all and
 every person or persons claiming or holding under
 them the said 1st party and also against the
 lawful title claim or demand of all and every
 person or persons whosoever claiming or holding
 by from or under the Government of the United
