to them and use and behoof forever And we do covenant  
with the said John S. Crammell & to his heirs and assigns  
that we are lawfully seized in fee of the aforegranted  
premises that they are free of all incumbrances that we  
have a good right to sell and convey the said land and  
premises to said Crammell & to his heirs and assigns  
and that we will warrant and defend the said premises  
to the said John S. Crammell heirs and assigns forever  
against the lawful claims and demands of all persons
