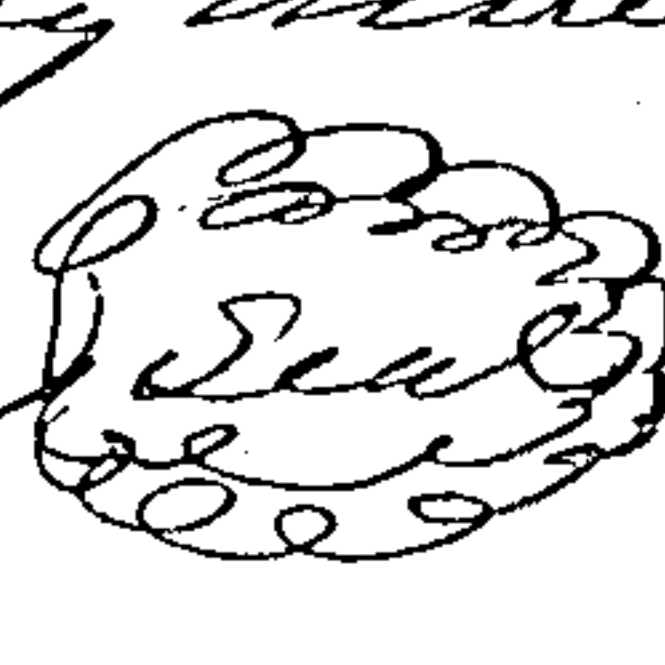


Nelson Know all men by these Presents that I Alexander

 three Township twenty four of Range twelve
 East on South side of Shoal Creek - also
 fractional part of section three Township
 Twenty four Range twelve East in all
 four hundred and fifty three acres more
