This Indenture, made this 16th day of February
One Thousand Eight hundred and fifty three
between Willie Horton & Elizabeth H. Horton husband
and wife of the County of Shelby in the State
of Alabama of the one part and Isaac W. Edwards
of the other part Witnesseth that the said
party of the first part for and in consideration of
the sum of Twelve hundred dollars to them in
hand paid the receipt whereof is hereby acknowledged
have this day bargained granted sold aliened enfeoffed
and conveyed and by these presents do bargain sell
enfeoff and convey to the said Isaac W. Edwards
all that certain tract or parcel of land lying &
being in the County of Shelby and State of Alabama
and known and distinguished in the plan of survey
of said State as the West half of the South East fourth & the
North East fourth of the North East fourth of the
North East 1/4 of the North East fourth and a strip off the west side
of the S.W. 1/4 of N.E. 1/4 supposed to be 6 to 8 acres more or
less and a strip off the S.E. 1/4 and of the S.W. 1/4 of N.E. 1/4 on
the North side thereof — supposed to be Eight acres more
or less as per a cardinal line made in and between
said Willie Horton and Wife & Horton all in section 33
Township 21 Range 1 East and also the N.E. 1/4 of South East
quarters of section 34 Township 21 Range 1 East
in all containing one hundred and twenty five acres
more or less To have and to hold the above
described tract or parcel of land together
with the tenements thereto belonging

or in anywise appertaining unto the said
 Isaac W Edwards his heirs and assigns forever
 And the said Miles & Elizabeth Horton for
 themselves their heirs Executors & administra-
 tors do warrant & well forever defend the
 title to the above described and hereby
 granted premises unto the said Isaac W
 Edwards his heirs and assigns forever and
 against themselves and all and every
 person or persons claiming or holding
 under them the said Horton &
 Horton and also against the lawful
 title claim or demand of all and every
 person or persons whosoever claiming
 or holding by force or under the Government
 of the United States In testimony whereof

 unto set their hands and seals this day
