 dec'd. who was a daughter of the said Henry

 said parties of the first part have sold to

 described land that is their interest and claim
 therein & to have the South East fourth

 all of Range one East Tuskaloosa Land
 District it being the land inherited by
 them of their said ancestor for and in
 consideration of the sum of seven teen
