This Indenture made and entered into this
 26th day of July A.D. 1855 between H. W. Nelson
 Sheriff of Shelby County State of Alabama of the
 one part and the other party of J. P. West of the same County
 and State of the other part witnesseth that on the 27.
 day of March 1854 a decree was rendered by the
 Probate Court of said County in favor of Harvey
 Cost against B. H. Randall et al. for \$967.00 dollars
 besides costs of suit that execution issued out
 of said court on the 29th day of May 1855 directed
 to any Sheriff of the State commanding the Plaintiff
 said execution came to the hands of H. W. Nelson
 Sheriff as aforesaid and was by him levied from
 the 6th 1855 on the following land as the property of
