Halladega County Alabama the receipt whereof in
full is hereby acknowledged do hereby give grant
bargain sell and convey unto the aforesaid Dan-
iel C. McIntyre and Elijah A. McKinnzie their
heirs and assigns forever a certain tract or par-
cel of land with all the privileges and appur-
tenances to the land belonging or in any wise

as pertaining situated in Shelby County Alabama
 and known and described as follows viz: The North
 West quarter of the North East quarter (N E 1/4) of
 Section twelve (12) in Township twenty two (22)
 of Range one (1) East Containing thirty nine ^{83/100}
 acres to have and to hold the above granted premises
 to the afore said Daniel C. McIntyre and Elijah
 A. McKenzie their heirs and assigns to them and
 their use and behoof forever. And we the said
 William Wresery and Sallie Wresery wife of said
 William Wresery for ourselves our heirs executors
 administrators and assigns that we are lawfully seized
 in fee simple of the aforegranted premises that
 they are free from all encumbrances and that
 we have a good right to sell and convey the
 same as aforesaid to the said Daniel C. McIntyre
 and Elijah A. McKenzie their heirs and assigns forever
 and we will and our heirs and executors and assigns
 shall warrant and defend the same to the said
 Daniel C. McIntyre and Elijah A. McKenzie
 their heirs and assigns forever against the law-
 full claims and demands of all persons in witness
 whereof the said William Wresery and Sallie W-
 resery (wife of the aforesaid William Wresery in to-
 ken of my release of all right and title of or to
 dower in the above granted premises) have here-
 unto set our hands and seals this the 26th day of
 January in the year of our Lord eighteen hun-
 dred and fifty seven
