 the party of the first part to be executed
 in due form of law and measures by virtue
 of said executions the party of the first part

 parties of the third part entered into a written agree-
 -ment to purchase said land at Sheriff's Sale
 and upon such Sale and purchase to own said
 land in proportion to the amount of their said
 several Judgments and whereas the parties of
 the third part have advanced & agreed to advance
 -two per Cent upon their respective Judgments
 for the purpose of paying to said Sheriff power
 execution liens upon said land in his hands for
 Collection and to let the title from said Sheriff
 to the party of the second part in trust for their
 benefit and whereas by virtue of said liens the
 said Sheriff offered said land for sale in
 the Town of Monteville on Monday the 27th day
 of October 1837 according to previous adver-
 -tisement at public Auction for Cash to the
 highest bidder and at said Sale W H Fell
 -was as agent for the parties of the third part
 purchased said land in the name of said

Joseph R John in trust as aforesaid at & for the sum of twenty five hundred dollars that being the highest & best bid now therefore the party of the first part in consideration of the promises & in consideration of said sum of twenty four hundred dollars in part credited upon said executions of the party of the third part, and in part paid in cash in discharge of executions having prior liens upon said land as aforesaid, by the said agent of the party of the third part at & before the ^{very} delivery & delivery of these presents has granted conveyed & sold by these presents does grant bargain & sell to the party of the second part this heirs & assigns forever all the right title & interest of the said George & Shortridge in & to the herein before before described tract or parcels of land lying & being in Shelby County & State of Alabama to have & hold by said party of the second part in trust for the parties of the third part in proportion to the amount of their said several executions with all & singular the terms & c & c thereto belonging. In Witness whereof the party of the first part has hereunto set his hand & affixed his seal the 27th day of September AD 1858. and the said agent in & for the parties of the third part is hereunto attested & forms part of this deed
