 Shulby County 3 and entered into the
 fourth day of November 1838 between Russel
 B. Williamson of the first part and Hudson W.
 Wilson of the second part Witnesseth that whereas
 the said party of the first part is indebted by
 Judgment to the amount of three hundred
 and thirty dollars the said Judgment being
 the balance due on the following tract or
 parcel of land to wit NW 1/4 of SE 1/4
 of NW 1/4 of Section 29 Township 19 of Range East
 as well as the further sum of one hundred
 and fifty dollars ^(153.16) due by promissory
 note due on the fourth day of December 1839
 to the said party of the second part and
 the said party of the first part being desir-
 ous to secure to the said party of the second
 part the above described amounts

Are therefore in consideration of the prom-
 -ises as well as the further sum of one
 dollar in hand paid the receipt whereof
 the said party of the first part does hereby
 acknowledge the said party of the first part
 hath sold and hereby sells and conveys to
 the said party of the second part the
 following property to wit the NW 1/4 of SE 1/4
 & the SE 1/4 of NW 1/4 of Sec 29 T 19 R E East
 lands lying in Shulby County Ala
 to have and to hold in trust as follows
 It is hereby agreed that the said party
 of the first part shall fully pay all
 claims to be paid to the said party of
 the second part the amount due on

Said Judgment as well as said note of one hundred & fifty three dollars and all reasonable charges for recording the instrument by the 4th day of December 1839 then the instrument is to be null & void otherwise should the said party of the first part fail to pay said sum of money as above specified then the said party of the second part is empowered to seize take into his possession the above described tract or parcel of land and after giving thirty days notice by advertising the said land at three public places in said County till the same to the highest bidder in the Town of Harpersville in said County & after giving the above described amount pay over the balance if any to the said party of the first part In testimony whereof we the said parties have hereunto set our hands and seals the day and date herein above written
