the further consideration that I have
executed my promissory note due and
payable to Geo. A. Logan of Outanga
County and State of Alabama on or before
the ninth day of February one thousand
eight hundred and sixty two in the
sum of three thousand dollars with
interest payable annually from date
thereof and dated the ninth day of
February 1859 And for the purpose
of securing the payment of the said
promissory note do hereby give grant
Bargain and sell and convey unto the
said Geo. A. Logan his heirs and
assigns forever certain tracts and
parcels of land lying and being
in the county and State aforesaid
known as the $N\frac{1}{2}$ of $W\frac{1}{4}$ & a part
of $S\frac{1}{2}$ of $W\frac{1}{4}$ $N\frac{1}{2}$ of $S\frac{1}{4}$ all in $S\frac{1}{2}$
Township 21 Range 1 East $W\frac{1}{4}$ and $S\frac{1}{2}$

 following Negroes to wit Dick a negro
 man aged about 50 years Creasy a woman
 about 30 years and Addie about
 12 years old and the Child Susan a
 girl about 2 years old also Peter
 a boy about 14 years old Paul a boy
 about 10 years old Fanny a woman
 about 25 years old and her three chil-
 dren Thomas 4 years old and Wesley
 2 years old and Shamash an infant
 about three months old to have and to
 hold all and singular the above named
 Negro Slaves unto the said Geo. A. Logan his heirs
 Executors administrators and assigns to him and
 them sole use force and of the said Isaac
 W. Edwards for myself my Executors & adminis-
 trators do Covenant the said Geo. A. Logan his
 heirs Executors administrators and assigns that
 I am lawfully seized and possessed of the above
 said and Negroes as of my own property that
 the same are free from all encumbrances
 and that I will my Executors &c. shall wa-
 rant and defend the same to the said George
 A. Logan his Executors &c. against the lawful
 claims and demands of all persons whatsoever
 provided nevertheless that if the said Isaac
 W. Edwards his heirs Executors &c. shall pay unto
 said Geo. A. Logan his Executors administrators &c.
 the said promissory note and the interest on
 the same then the said promissory note & the
 instrument shall both be absolutely void to
 all intents and purposes but if default be made
 in the payment of the Money of said or the
 interest that may grow due thereon or any
 part thereof then it shall be lawful for the
 said George A. Logan his Executors adminis-
 trators and assigns to enter into and upon all
 and singular the premises hereby granted or
 intended to be granted and to sell and
 dispose of the same and all benefits and
 equity of Redemption of said Isaac W. Edw-
 ards the Grantor his heirs Executors adminis-
 trators or assigns thereof at public auction
 upon the premises hereby granted first giving
 thirty days notice by advertisement in any
 news paper that may be at that time pub-

lished in the County of Shelby, and by or their
 own name or as the attorney of the said Isaac
 W Edwards, the Grantor for that purpose duly
 authorized constituted and appointed to make
 and deliver to the purchaser or purchasers of said
 land, good and sufficient deed or deeds of Con-
 veyance for the same in full simple, and to
 deliver to said McGraw, to the purchaser
 or purchasers of the same at the said sale
 and out of the money arising from such
 sale to retain the principal and interest
 which shall then remain due of the m-
 ony mentioned in the Constitution of this
 said aforesaid together with the cost and
 expenses of advertising and selling said land
 and McGraw including the one half of any
 to the said Isaac W Edwards, being Execu-
 tors &c of which sale to be made shall
 forever be a perpetual bar both in law &
 Equity against said Isaac W Edwards
