One East and the NW $\frac{1}{4}$ the W $\frac{1}{2}$ of the SW $\frac{1}{4}$ and the
NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section nineteen and the W $\frac{1}{2}$
