 entered into this 19th day of October A D 1859
 between A A Sterrett and Elizabeth M Sterrett
 husband and wife and Saml B Roper of the
 first part and B O Nabors of the second part
 witnesses. That the said parties of the first part
 for and in consideration of the sum of one hundred
 + twenty four dollars to them in hand paid by
 the said party of the second part, the receipt whereof
 is hereby acknowledged, have sold and hereby
 sell, confirm and convey unto the said party of
 the second part the following described land
 lying in said Shelby County, State of Alabama
 to wit all of that certain lot lying & being in the
 Town of Columbiana, beginning at the South
 East corner of a certain lot in said Town heretofore
 sold by said Sterrett & wife to one Wm J. Hallinan
 thence west along the line of said lot to the
 South West corner thereof to a stake on the eastern
 boundary of a lot sold by said Sterrett & wife
 & Roper to J M Jones, thence south along the line
 of said J M Jones lot to a stake at the NW
 corner of a lot sold by the same parties

to Wm M Allen or W H Carroll now occupied by said
 Carroll therein East parallel with said first line to the
 public Road running north from the Court House being
 the North East Corner of said Carrolls lot thence along
 said public road to the beginning at the South East
 corner of said Hallman Lot containing about two acres
 in it more or less to have and to hold to said second party
 his heirs and assigns forever the above described and hereby
 granted lands, and premises. And the said parties of
 the first part husband and wife hereby covenant with
 the said party of the second part that they are lawfully
 seized of and have good right to sell and convey said
 land and hereby bind ourselves, our heirs and legal
 representatives forever, to warrant and defend the title
 to said land and premises to the said party of the
 second part his heirs assigns and legal representatives
 against the claim of all and any person in law or
 Equity: ayd against the government of the United
