 H. Robert ^{and wife Elizabeth M. Robert} of the County of Jefferson State of Alabama of
 the first part and Gray Buckalew of the County of Geneva
 and State aforesaid of the second part (hereinafter called the
 said Alfred H. & Elizabeth M. Robert) parties of the first
 part for and in consideration of the sum of fifteen
 thousand dollars to them in hand paid the receipt
 whereof is hereby acknowledged have granted bargain
 ed and sold conveyed and confirmed and by these
 presents do grant bargain and sell convey and con
 firm into the said Gray Buckalew party of the second
 part the following described tracts and parcels of
 land situated lying and being in the County of Shelby
 State of Alabama and known as follows to wit the Wth
 of the North East quarter and the North West Quarter and
 the West half of the North West Quarter all in Section one
 Township 33rd Range 3 West and the East half of the North

East Quarter of Section 2 Township 23 Range 3 West and
 the West half of the North East Quarter and the South
 West Quarter all in Section 34 Township 21 of Range 3 West
 and the North West Quarter of the North West Quarter of
 Section 32 Township 21 Range 2 West and the South half
 of the South East quarter and the South East quarter
 of the South West quarter of Section 27 Township 21 Range
 3 West containing about eight hundred acres To have
 and to hold to him the said Gary Huelahed trustee of
 the second trust his heirs and assigns in fee simple
 forever the said tract and parcels of land with
 all the tenements and improvements thereto belonging
 or in any wise appertaining and the said trustees
 of the first trust do hereby warrant and defend the
 title to said tract and parcels of land to said Gary
 Huelahed his heirs and assigns against the claims
 of all and all persons (whatsoever)
