 Shelly County 3 Come Or whom it may in any
 wise Concern Know Ye that by a certain deed of trust
 made by Hiram W. Sawley the debtor, Hudson McKelton
 the Creditor & R. S. Philip the Trustee on the 11th day
 of October 1860 and Recorded in the office of the
 Probate Court of said County in Record Book
 N On Page 503 & 504 which which deed of trust
 was conveyed by said Sawley to said Philip the
 following described tract or parcel of land
 situated in said County and known as the
 East half of the North East quarter & the
 North West quarter of the North East quar-
 ter & the North West quarter of the South West
 quarter of Section five in Township Eighteen of Range
 Two East in trust to secure the payment
 of a certain debt in said deed of trust men-
 tioned due from said Sawley to said McKelton. The
 said Sawley having failed to pay said debt in said
 deed of trust ~~mentioned~~ and the remaining due and
 unpaid of the said Robert S. Philip the trustee
 as authorized and empowered by said deed
 of trust at the request of John W. Mc-
 Kellahan to whom the debt due from said

Lawley to Said Nelson had been assigned & transferred
 by Said Nelson did on Saturday the 13 day of October
 1866 at the Residence of Said Lawley & on the Said tract
 of land within the legal hours of sale having given the
 time place and Terms of Sale of Said tract and
 parcel of land as required by the Said deed of trust
 in default of payment of the Said debt therein mentioned
 proceed to sell the Said tract and parcel of land
 to the highest bidder for Cash when and at which
 Said Sale the Said John W McLanahan become the
 purchaser he being the best & highest bidder for
 the same at the sum of One hundred and Twenty five
 Dollars, & the Said sum of One hundred twenty five
 Dollars being credited on Said debt in part payment
 of Said debt. Now therefore the Said R L Flipin
 trustee in Said deed of trust as such in consideration of
 the premises and of the payment of the Said sum of
 One hundred and twenty five Dollars which the Said tract
 and parcel of land was bid on and sold by being
 credited on Said debt in part part thereof by Said McLanahan
 have to whom Said debt was assigned and
 transferred as aforesaid have bargained and
 sold and do fully sell & convey the
 Said tract or parcel of land unto the Said
 John W McLanahan to have and to hold
 the same to himself his heirs and assigns for
 ever, that is to say all the right title
 & interest claim & demand which the
 Said Lawley had of in and to Said tract
 or parcel of land and which was by him
 conveyed by Said deed of trust as aforesaid
 In witness of all of which the Said
 R L Flipin trustee as aforesaid here to set
 my hand and seal this the 15 day of October
