

The State of Alabama, Know all men by these presents that Ephraim  
 Shelly County A Lindehardt of said County and State are signed  
 in fee of in all those lots and parcels of lands situate and lying in  
 the Town of Columbiana in said County and State on the Road or Street  
 running through said Town East and West and known as the Mardis  
 lots on which the Honorable A B Mardis now resides being now in  
 his said Mardis possession & occupation & also of all that certain  
 lot and parcel of land situate in said Town of Columbiana and  
 known as the Paragon. This last lot containing one and a half or two  
 acres more or less. Now in the possession of John Baker and also  
 of all that tract and parcel of land bought by one of Thos H Prosser  
 or and lying between the dirt Road from Columbiana to A M Ellistons  
 on the North and a crop fence on the South and West the line of that  
 part of said tract sold by one to said A B Mardis containing about fifty  
 acres be it more or less the Numbers of said tracts or lots of land  
 not distinctly remembered now known to that I the said Ephraim A  
 Lindehardt have made constituted and appointed & by these presents do make  
 constitute and appoint A A Sturtt of said Town my true and lawful attorney  
 for me & in my name to rent or lease the said several lots tracts and parcels  
 of land with the premises to such person or persons & for such time  
 and upon such terms as he my said attorney shall see fit; or otherwise  
 and whenever he may have an opportunity to sell and dispose of the  
 same or any or either of said lots & tract of land or any part or parcel  
 thereof in fee simple for such price or sum of money and to such person  
 or persons as he my said attorney shall see fit & convenient. And also for me  
 & in my name & as my act and to sign seal execute & deliver such deeds &  
 conveyance for the renting leasing or absolute sale & disposal thereof  
 or of any or either or any part thereof with such clauses covenants or  
 agreements, to be therein contained as my said attorney shall deem  
 fit & expedient, and I do also confer upon my said attorney full  
 power & authority to make nomination & appoint when he may  
 think proper a substitute & attorney for me to act in the premises  
 hereby ratifying & confirming all such leases renting deeds conveyances  
 bargains and sales which shall hereafter at any time be  
 made by my said attorney or any one substituted  
 by him touching or concerning the premises And for the  
 purpose of making and securing a perfect title in case of sale  
 of any either or all of said tracts & parcels of land  
 I Julia Lindehardt wife of the said Ephraim A  
 Lindehardt have and do join with the said Ephraim A  
 Lindehardt my husband in this power of attorney  
 and fully authorize and empower the said A A  
 Sturtt or substitute under him in case of sale as  
 afore said of either or any or all of said tracts  
 of land to sign seal execute & deliver for me and  
 in my name release and relinquishment of  
 power that I may be entitled to in or to any  
 or all of said tracts of land & premises as I my
