 Iron Company has granted bargained sold and Conveyed
 and does by these presents grant bargain sell and Convey
 to the said Edwards his heirs and assigns the hereinafter
 designated tracts or parcels of land situated in the State and
 County aforesaid: That is to say: That part of the South East
 quarter of South West quarter of Section sixteen (16) Township
 twenty four (24) North, of Range Fifteen (15) East lying east of a
 line drawn from the North East Corner to the South West Corner
 of said forty acre tract, and that part of the South West quar-
 ter of South East quarter of said Section Sixteen (16) lying
 west of a line drawn from the North East Corner to the South
 West Corner of said forty acre tract. Also the North East quar-
 ter of the North West quarter and the South West quarter of the
 South West quarter of Section twenty one (21) Township Twenty
 four North of Range Fifteen (15) East the title to which tracts or
