

Porrell May B. State of Alabama, Know all men by these presents that I May
 B. Shelby County S. B. Porrell have for and in consideration of the
 love and affection I bear to my daughter Martha H. Hale
 bargained granted given and conveyed & by these presents
 do bargain grant give and convey to her her heirs and as-
 signs forever all the right title interest and estate which
 I have and hold in the following described tracts lots &
 parcels of land with all buildings implements improve-
 ments and appurtenances therunto belonging viz the lots
 in the original plat of the Town of Montevallo of said
 County numbered as follows forty six Forty nine Fifty
 and fifty one the lot fifty containing about four
 acres the others about two acres each Also I give her
 the following described tracts of land lying about
 three to four miles east of Montevallo with all things
 thereon as above stated The South East $\frac{1}{4}$ of Fractional
 Section 23 Township 22 Range 3 East about 148 acres
 and S E $\frac{1}{4}$ of N E $\frac{1}{4}$ same section and S W $\frac{1}{4}$ Fractional
 Section 24 about 100 acres and West half N W $\frac{1}{4}$ same
 section known as the Arnet home place Also the East half
 of the N W $\frac{1}{4}$ and the West half of the N E $\frac{1}{4}$ and the South
 East $\frac{1}{4}$ of the N E $\frac{1}{4}$ of section 24 same Township & Range
 as next above written and all the South East Fraction
 of same section except forty acres off of the East end
 of said South East Fraction and all that part or por-
 tion of the N W $\frac{1}{4}$ of the N W $\frac{1}{4}$ of section five Township
 24 Range 13 East which lies on the North side of the
 Alabama & Tennessee River Rail Road and all that
 part or portions of the N E $\frac{1}{4}$ of the N E $\frac{1}{4}$ of section
 six same Township & Range as next above written
 which lies on the North side of said Rail Road
 And the S E $\frac{1}{4}$ and East half of S W $\frac{1}{4}$ and East
 half of N E $\frac{1}{4}$ of section two Township 24 Range
 12 East and North half of Fraction A section

12 same Township and Range as next above written. I furthermore
 Covenant with the said Martha H. Hale her heirs and assigns
 that I have the right to give grant and convey the above de-
 scribed lands & appurtenances in fee simple (except the Ten yard
 lot which is a part of lot number Forty six in the town of Mon-
 terallo & was omitted to be mentioned above as belonging to the
 estate of Martha A. Holbrook and which I do not pretend to
 convey) And that I will forever defend and do hereby bind my-
 self my heirs and assigns to defend the said Martha her heirs
 and assigns in the peaceable use and possession of the said
 lands and premises against the legal claims of all persons
