 Swift Shelby County } this 25th day of January 1879, between David M
 To Ray and Mary Ray debtor of the first part and Super & Co
 Super & Co Creditor of the 2nd part, witnesseth: That whereas the said party
 of the 1st part is justly indebted to the party of the 2nd part
 in the sum of Seventy dollars due by waive - and paya-
 ble on or before the 1st day of Nov 1879: and the said party of
 the 1st part being desirous to secure the payment of said
 indebtedness: for and in consideration thereof the said
 party of the 1st part has sold and hereby sells and con-
 vey to the said party of the 2nd part the following described
 property to wit: One Ox (white & dun pided about 4 years old)
 One cow Black & white spotted and one yearling white & black
 spotted, and the entire crop raised by the parties of the
 1st part in the year 1879 - To have and to hold in trust
 as follows: It is hereby agreed that the said party of the 1st
 part is to have and retain possession of the said property
 until the 1st day of November 1879: And if the said party of the
 1st part shall fully pay to the said party of the 2nd part
 said debt, reasonable expenses hereof by said 1st day of
 November 1879, then this indenture is to be null and void,
 But upon default of such payment the said party of the
 2nd part is hereby authorized to take into possession and
 sell said property to the highest bidder for cash at such
 time and place as he may select after giving 10 days
 notice of the time and place of said sale by posting at
 three public places, and out of the proceeds of said sale re-
 tain the sum of Seventy dollars and the reasonable
 costs hereof, and the balance, if any, pay to the said
 party of the 1st part. And it is agreed the party of the
 2nd part may purchase at said sale.
