 hereby reserved together with the
 right to mine same
 To have and to hold to the said
 R.M. Payne his heirs and assigns
 forever and the said Saginaw
 Lumber Company will and its
 successors and assigns shall war-
 rant and defend the same to the
 said R.M. Payne his heirs executors
 and assigns forever against the
 lawful claims of all persons. In
