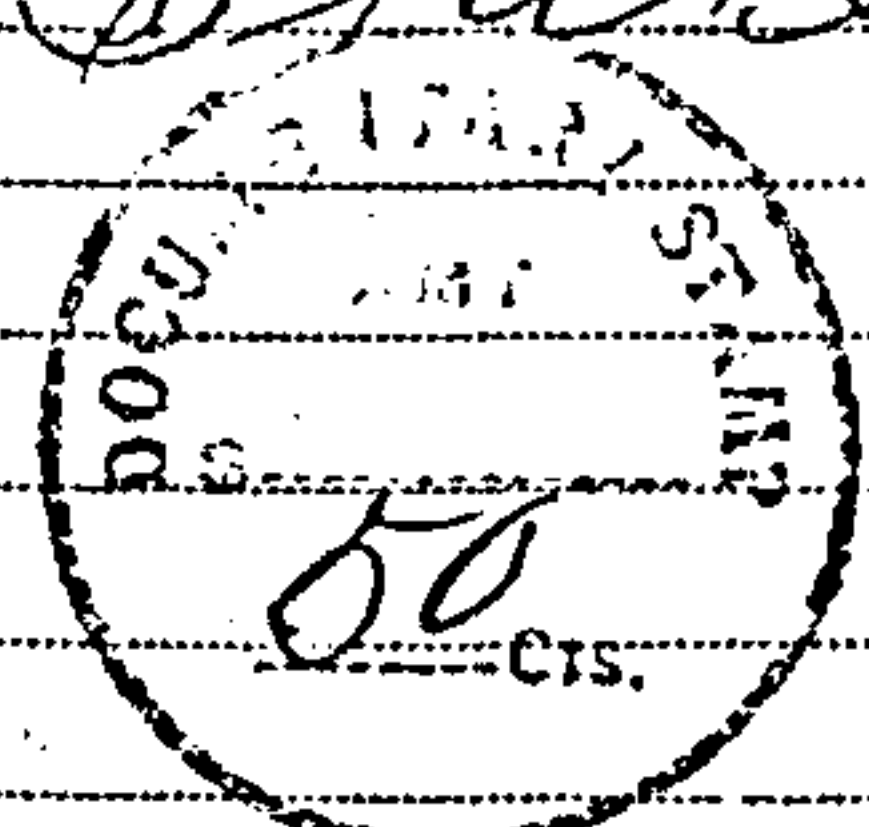

One hundred and fifty on Gardner Street

they are free from all incumbrances; that I have a good right to sell and convey the said property; that I will, and my heirs, executors, and adminis-

trators shall, warrant and defend the same to said Mary J Wade
heirs, executors, and assigns, forever, against the lawful claims of all persons whatsoever.
