To hav an hold to said party of the second part his heirs and assigns forever the above described land and hereby granted lands and premises and the said paties of the first part husband and wife hereby covenant with the said party of the second p art that they are lawfully seized of and hav a good right to sell and convey said lands an hereby bind themselves their heirs and legal representatives forever to warrant an defend thetitle to said land an premises to the said party of the second part his heirs and assigns and legal representatives against the claims of all ~~land~~ and every parson in law or equity and ~~xxx~~ against the govenment of the United States.
