Those parcels of land lying in Shelby County, Alabama, one commencing at the ford of Beaver Creek where the Montevallo Road crosses said Creek and beginning in the centre of the run of said creek, thence down the centre of said creek as it runs to a point opposite Dan White's line, thence East to the South west corner of Lee Wilson's lot and Henry Stores, to the section line dividing section thirteen and twenty four, thence west to the corner dividing the lands of M. J. Horton , and Shelby Iron Company, thence North to the old Spring Branch, thence down said spring branch six poles, thence west of north to the Montevallo road, thence along said road to the point of beginnig, containing twenty seven adres more or less, ^{Each} Also the South East Quarter of South West Quarter of Section Fourteen, Township Twenty-two Range one W Containing forty acres more or less.
