Witnesseth: That the said xxx parties of the first part, for and in consideration of the sum of—— One thousand and sixty Dollars in hand paid the receipt whereof is hereby acknowledged, in oredfr to make this conveyance absolute, the parties of the first part, have this day bargained sold and conveyed and by these presents do bargain sell and convey unto the Lathorp Hatten Lumber Company a corporation and to its Junicens at Elling and up at Zing of cutting successors and assigns, all the merchantable kxingkex timber on the following described land to—wit: The S 1/2 of SE 1/4 of Section 34, in Township 17 south of Range 2 East in St Clair County Ala., and SW 1/4 of NW 1/4 of section 3 and 5 acres more or less, on

East side of SE 1/4 of NE 1/4 and E 1/2 of SE 1/4 of Section 4 and E 1/2 of NE 1/4of Section 9, in Township 18 south Range 2 east in Shelby Co., Ala containing in all 180 acres more or less, lying and being in said Counties. And the parties of the first part covenant that the said timber and the said lnads are free from all incumbrances, that they have a good right to sel 1 And convey the said timber and that they will warrant and dxxxxxx forever defend the title thereto against all lawful claims, with all the rights and privileges hereinbefore and hereinafter in this deed conveyed. And the party of the first part hereby, in consideration of the prem ises furthEr agree that the Lethorp Hatten Lumber Company shall have and they hereby grant them until the 12th day of November 1906 within which to cut and remove from said lands the timber hereby conveyed to said grantee; and the Lathorp Hatten Lumber Company shall have during said time full xx right of way xxxxxx over and across said landx and any other land, and also any other lands owned by either of the parties hereto, for the purpose of removing any of their timber; and the right if grantee so desires, to build a true road, railroad, pole road ob other road, or other road over and across any part of said lands for that purpose.
