A Part of Lot number twenty-five (25) in the town of Montevallo, according to the original plan of said town; the said part hereby Resurveyed being described and bounded as follows, to-wit: Commencing at the northemmost corner of said Lot, being at the intersection of Valley and Vine Streets and running thence in a South-east direction, along the margin of said Vine Street, one hundred (100) feet; thence in a South-west direction, parallel with said Valley Street, a distance of seventy-five (75) feet, more or less, to the dividing line between said lot number twenty-five and lot number twenty-four; thence in a north-west direction, along the said dividing line, one hundred (100) feet, to the margin of said Valley Street, and thence in a north-east direction, along the margin of said Valley Street, seventy-five (75) feet, more or less, to the point of beginning; being a part of the lot heretofore known as and called the "J.M.
