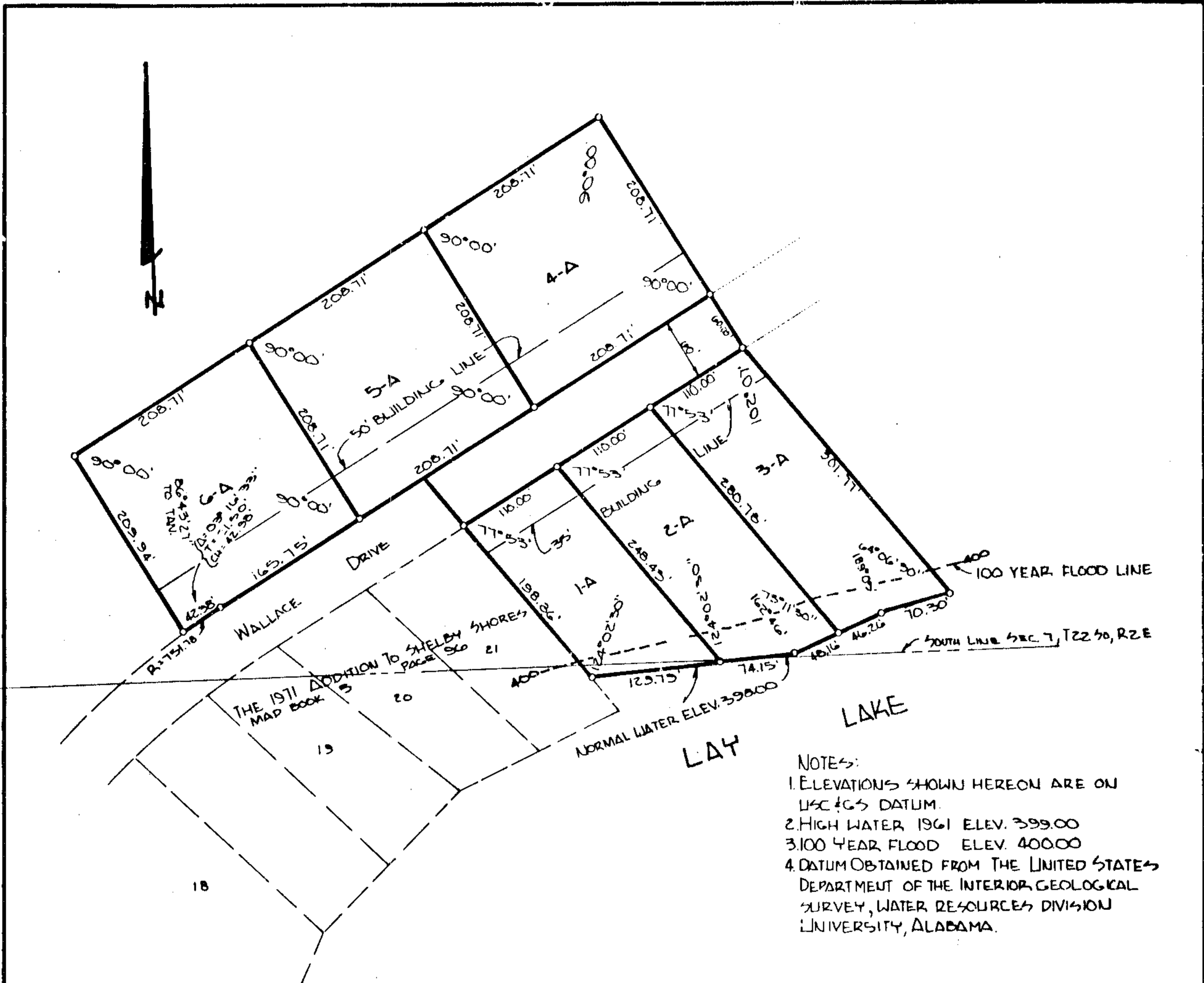

THIS SUBDIVISION IS CONTINGENT UPON THE FOLLOWING RESTRICTIONS:  
 PUBLIC WATER IS TO BE PROVIDED BY THE SPRING CREEK WATER AUTHORITY  
 NO PORTION OF THE DWELLING OR SEPTIC TANK AND DISPOSAL FIELD WILL BE LOCATED BELOW THE 100 YEAR FLOOD LINE, OR WITHIN 50 FEET OF THE NORMAL WATER LEVEL.  
 THE MINIMUM SIZE SEPTIC TANK SHALL BE 1000 GALLONS AND THE AMOUNT OF DISPOSAL FIELD IS TO BE COMPUTED.  
 PLOT PLANS FOR EACH LOT SHALL BE SUBMITTED TO THE SHELBY COUNTY HEALTH DEPARTMENT PRIOR TO BEGINNING CONSTRUCTION OF ANY DWELLING. PLOT PLANS WILL SHOW THE POSITION OF THE DWELLING ON THE LOT; THE LOCATION OF SEPTIC TANK AND DISPOSAL FIELD; THE LOCATION OF THE WATER LINE SERVING THE PROPERTY; WALKWAYS, DRIVEWAYS AND OTHER PERTINENT INFORMATION. THE ISSUANCE OF A SEWAGE DISPOSAL PERMIT IS CONTINGENT UPON APPROVAL OF THE INDIVIDUAL PLOT PLAN.  
 THE SOIL BORING ON LOT 6-A LOCATED ROCK AT 44". ADDITIONAL SOIL BORINGS WILL BE REQUIRED ON THIS LOT BEFORE A PERMIT CAN BE ISSUED. A SOIL BORING WILL BE REQUIRED ON LOT 5-A. THESE SOIL BORINGS SHALL BE MADE PRIOR TO SUBMITTAL OF THE INDIVIDUAL PLOT PLAN AND ARE TO BE MADE IN THE AREA WHERE THE SEPTIC TANK AND DISPOSAL FIELD WILL BE LOCATED.
