
LOCATED IN THE WEST 1/2 OF THE N.W. 1/4 OF SECTION 23, TOWNSHIP

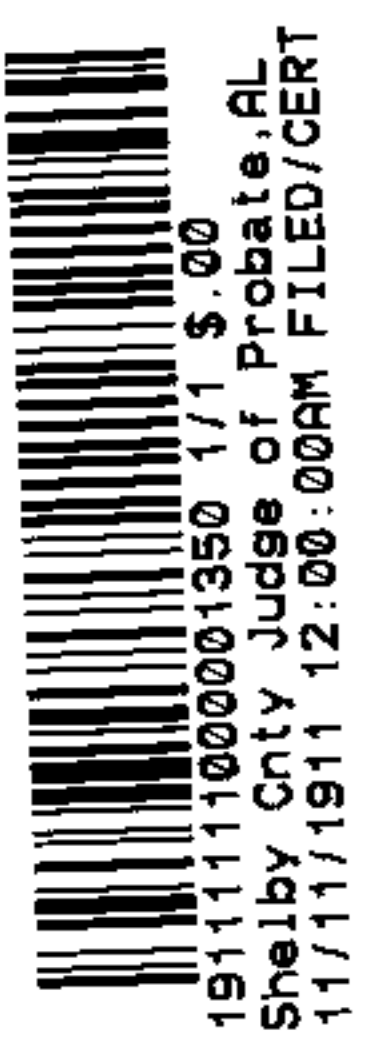
