

WARRANTY DEED.

KNOW ALL MEN BY THESE PRESENTS:

Shelby County. That for and in consideration of Three Hundred and fifty \$300.00 DOLLARS, to the undersigned Grantor, Charles Sparks, a widower in hand paid by William N. Keith the receipt whereof is hereby acknowledged, I the said Charles Sparks do Grant, Bargain, Sell and Convey unto the said William N. Keith the following described Real Estate, to-wit:

All of that certain tract or parcel of land lying West and North of Waxahatchee Creek in the N. W 1/4 of N. E 1/4 and all lands West of such Creek in the S. W 1/4 of N. E 1/4 and N. E 1/4 of N. W 1/4, all in Section 15 - Twp. 22, Range 1 West situated in Shelby County, Alabama, and comprising ninety-one acres, more or less, lying lands which were originally jointly owned by the said Charles Sparks, Grantor herein and Jefferson P.
