

State of Alabama I know all men by these Presents, That the County of Shelby I designed Shelby & Co. temporary a corporation for and in consideration of the sum of Forty (\$40.00) Dollars to it in hand paid by the Alabama Power Company a corporation the receipt whereof is hereby acknowledged does hereby grant to the said Alabama Power Company its successors and assigns, the right to construct, operate and maintain electric transmission lines and all telegraph and telephone lines, towers poles and appliances accessory or convenient in connection therewith upon a strip of land 50 feet in width, said strip of land and the lands of which the same is a part being situated in Chilton, Shelby and Talladega counties Alabama, and described as follows:

That certain strip being a part of the southwest quarter of the southwest quarter of section 32, Township 24, north range 15 east in Chilton County, Alabama, and more particularly described as follows: Fifty feet on each side of a line beginning at a point on the south boundary of the above described land, said point being east 850 feet from the southwest corner thereof, running thence north 54° west across said lands to a point on the west boundary thereof, said last named point being north 615 feet from the southwest corner of said section 32.

Also that certain strip being a part of the northeast quarter of the northwest quarter of section 32, Township 21, south range 2 west in Shelby County, Alabama, and more particularly described as follows: Fifty feet on each side of a line beginning at a point on the south boundary of the above described lands, said point being east 110 feet from the southwest corner thereof, running thence north 23° and 02' west across said lands to a point on the western boundary thereof, said last named point being north 30 feet from the southwest corner of the above described lands.

Also that certain strip being a part of the southwest quarter of the northeast quarter of section 19, Township 21, south range 2 west in Shelby County, Alabama, and more particularly described as follows: Fifty feet on each side of a line beginning at a point on the south boundary of the above described lands, said point being west 150 feet from the southwest corner thereof, running thence north 22° and 03' west across said lands to a point on the north boundary thereof, said last named point being east 625 feet from the northwest corner of said land.

Also that certain strip being a part of fractions A and B of section 24, township 22, south range 2 east in Talladega County, Alabama,

and more particularly described as follows: Fifty feet on the east side of a line beginning at point on the south boundary of the above described land, said point being west 70 feet from the southeast corner of said Fraction B, running thence north 53° and 38' east across said lands to a point on the eastern boundary of said section 24, said lot named point being south 70 feet from the northeast corner of said Fraction C. It being the intention that said strip shall be according to the final location survey thereof heretofore made by the said Alabama Power Company together with all the rights and privileges therein necessary or convenient for the full enjoyment or use thereof, for the purposes above described, including the right of ingress and egress to and from said strip; and also the right to cut and keep clear all trees and undergrowth and other obstructions on said strip, and danger trees adjacent thereto where necessary.

To have and to hold the same to the said Alabama Power Company its successors and assigns forever.
