Corner of the N.E 1/4 of Section 33, in such point as the Rear or East line of the flat now owned and occupied by the Baptist Church at Hartselle and the back of the ground and occupied front by B. E. Elliott - thence running East on said section line to the tract of land owned and occupied by Will Reed, which point is about 309 ft West of N.E. Corner of said Section 33, thence South along the West side of said Will Reed's tract a tract of land owned by Will Reed - about 457 feet to the lands of C. H.
