the following described Real Estate, to-wit:

That certain dwelling lot or parcel of land situated on the North side of Mildred Street in the town of Columbiana Shelby County Alabama, a part of which was purchased by the said Lorraine A. Gordon from Jas. H. Page as appears from and as described in a deed executed by the said Jas. H. Page and his wife Melvina Page to the undersigned Lorraine Gordon dated the 16th day of June 1914, and recorded in Volume 53 on page 491 of record of Deeds in the Office of Judge of Probate of Shelby County Ala. and a part of which lot herein conveyed was purchased by the said Lorraine Gordon from the undersigned Baptist Church as appears from a deed executed by W. L. Lempson, J. L. Tyler and others as Trustees of said Columbiana Baptist Church dated the 2nd day of May 1914, and recorded in Vol. 54 on page 482 of record of Deeds in the Office of Judge of Probate of Shelby County Ala. which said lot herein conveyed is more particularly described as follows to-wit: Beginning at the South West Corner of the lot owned and now occupied as a residence by George W. Green; the said corner being

a point 250 feet South of the North East Corner of the lot owned and now occupied as a residence by Jas. H. Page on the South side of Calleye Street, and running in a straight line with and a continuation of the line separating the lot of Jas. H. Page from the lot of Geo. W. Green a distance of 187 1/2 feet to a point on the North side of Mildred Street which said point is 160 1/2 feet East of the South West Corner of the lot of Jas. H. Page and the South East Corner of the lot of Mrs B. A. Milour; and running thence along and with the North side of Mildred Street a distance of 86 1/2 feet to a point on the South side of the lot known as the Baptist Pastorum lot, and owned by the Columbiana Baptist Church which point is 166 feet West of the South East Corner of said last named lot, and running thence in a straight line a distance of 250 feet more or less to a point on the Southern boundary line of the lot of George W. Green, 45 feet West of the South East Corner of said lot of George W.
