Now therefore in consideration of the premises and of the sum of sixty five and $\frac{83}{100}$ Dollars, in hand paid to me by the said party of the second part, the receipt whereof is upon delivery of these presents, hereby acknowledged, the said party of the first part has granted, bargained and sold, and does by these presents grant, bargain, sell and convey unto the said party of the second part the following described property tract, commencing at a point 5^{1/2} feet north of the main track
