Witnesseth, that, Whereas a mortgage was executed on the
5th day of May, 1914 by C. H. Frye of Shelby County, Ala., to
Citizens Bank, a corporation, on certain property herein

Now therefore in consideration of the premises, and of the sum of three hundred and forty (\$340.00) dollars, in hand paid to me, by the said party, of the second part, the receipt whereof is upon delivery of these presents, hereby acknowledged, the said party of the first part has granted, bargained and sold and by these presents does grant, bargain sell and convey, unto the said party of the second part the following described real property to wit: The East half of the North East quarter, ($\frac{1}{4}$ of $\frac{1}{4}$ NE $\frac{1}{4}$) and the East half of the South West quarter ($\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Five (5) Township Twenty four (24) Range Thirteen (13) East, containing one hundred and sixty (160) acres more or less, together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in any wise appertaining.

To have and to hold the said above described property unto the said Citizens Bank, a corporation, the party of the second part, and unto its successors and assigns, as fully and completely, in all respects as the said party of the first part can or ought to convey the same under and by virtue of the power and authority vested in him by the terms of said mortgage.
