Mercantile Company does grant bargain sell and Convey
unto the said R. C. Norris the following described real

River on the West boundary line of Sec. 24. Tp. 20 Range 2
East, run thence up said river with its meanderings 51.88
Chains to a fence, run thence North 61° West along said
fence 29.85 Chains, thence run North 20° West 9.08 Chains,
thence run North 32° West 11 chains, thence run South
16.59 chains to the West boundary line of Sec. 13 of said
